The Joint Core Strategy was currently under examination, which was a long process, the inspector had started in October 2014 and was still working through it.

An appeal by Hitchins relating to their proposals for 550 houses was held several weeks before and had been interesting. Now there was a wait for the inspector to come back with his opinion.

PA/07/16 Other Matters Raised by Electors

Mrs Shillam asked why the Council had changed the name of the Playing Field (previously Gould Field) and queried who would be funding the new signage. Cllr Terry explained that the Council had agreed to change the name of the Playing Field as a lot of people did not know where 'Gould Field' was. It was felt that changing the name to Northway Playing Field would make things easier. She added that Northway Community Volunteers (NCV) were funding the new signage and thanked them, on behalf of the Council, for this.

Mrs Shillam mentioned an overgrown hedge along The Park which meant that the footpath was not wide enough to allow for a pushchair to get past. Residents had been talking about putting together a petition to get this dealt with. The Clerk explained that the Council had written to the house in question a couple of weeks before, normally if action was not taken it would be passed on to Gloucestershire County Council.

Mrs Shillam felt that the Council would soon need to look into getting yellow lines painted on the road outside the new development on The Park (Harriers Close) as people kept parking there. PCSO James encouraged Mrs Shillam to phone 101 whenever she saw this happening, if it was causing an obstruction.
